- [10.5.3] You are required to have 3 days' worth of emergency lesson plans on hand.
- [10.6] Your duty day starts 15 minutes before the students arrive, and ends 15 minutes after they leave.
- [10.7.7] "Coach Class" helps to meet your requirement to meet with students for reinforcement and remediation.
- [10.13] You are entitled to 30 minutes, duty-free, for lunch. You are entitled to 250 minutes per week of planning time. Special Educators and related service providers may request more time for case management.
- [10.13.6] Teachers who are assigned more than 3 preps are not to be given other duties.
- [10.14] Schools are encouraged to hold their faulty meetings on Mondays after school.
- [10.17] You will find both curriculum and gradebook in Schoology, via BCPS One. Your planning materials are your own, but the gradebook is BCPS property.
